

Getting More Out of Your Company's Tax Deductible Contributions

Where is your treasure? Is it secured? Is it backed by the God of this universe? Or is it backed by man and only temporal? You can give to support the work of Trinity Baptist Temple, specifically our mission board, Southeast Asia Baptist Missions, and help lay up treasure in Heaven at the same time. So, what are we doing?

Trinity Baptist Temple started Southeast Asia Baptist Missions (SEABM) because we felt lead to that region. SEABM locates, trains, and supports local pastors. Through this they can preach the gospel, train their people, and begin to plan new churches.

1. It is easier for a local national to go into other Southeast Asian countries than Americans. We support and train them to grow the gospel in their area and to develop others who will travel and plant other churches.
2. We have felt lead to Southeast Asia. That is why we started Southeast Asia Baptist Missions.
3. We put on marriage conferences in the Philippines to encourage, strengthen, and train the people.
4. We support local pastors financially and give guidance and advice.
5. We help them spread the gospel around the area and support additional pastors.

What are the benefits?

Local pastors do not have to worry about the language, cultural or financial obstacles such as health insurance, private schooling, and air conditioned housing that face non-national missionaries.

1. Mission boards estimate it takes \$5,250 per American sent missionary family per month in the Philippines.
2. A local pastor can be supported for only \$50 per month! (Represents 15 to 20% of their monthly expenses.)
3. Over 100 to 1 support potential by locating, training, and supporting local pastors.
 - a. Spreading of the gospel is increased significantly.
 - b. Help them grow their congregations to be self supporting and use their support for another pastor.
4. In Vietnam a \$40 bag of rice will feed 9 widows three meals a day for a month.

What is the need?

Trinity Baptist Temple believes we need to send missionaries from our churches across America to the mission field, as well as support local pastors across the world. This two-fold approach spreads the gospel and strengthens the foundation of the church. Many organizations are sending and supporting logistics for missionaries from America, but few are supporting local pastors across the world. TBT is filling the void.
